# **Public Input:**

John Hart asked to be heard in regards to his application for Agriculture exemption and the Schedule "F" form which was to be filed. He asked for a copy of his forms handed in previously.

## **Reports:**

Code Enforcement Officer: Report submitted for review. Dave Rackmyre, Jr. has issued 5 permits, had several code related calls and inspections. He will be issuing tickets of some violations sent last month. He is asking the Board if they would like to add a fee for pool permits or not. The board's decision will be made as the updating of the codes are being done.

Planning Board: Report submitted for review. The Board is looking toward late August or September, 2011 for a Public Hearing on the proposed CG Roxane Water Bottling Plant.

<u>Highway Superintendent:</u> Black Topping is all done. The Dept is now in compliance with the Mining Safety by completing CPR/First Aid, etc. MSHAW inspected again and gave the compliance. Health Dept came for an inspection, issued 1 citation regarding a plug/lead cord. Jim will be walking the roads with Jim Mraz and Mark Yost checking on what needs to be done for the possible construction for the bottling plant.
