- Working on the 13 violations with the oil tanks
- The State Dept of Environmental Conservation inspected the floor drain in the Hwy garage. Found a problem with the oil/water separator in the floor drain. A SPDES permit application would require the design plans for the existing system be stamped and submitted by a licensed professional engineer along with the appropriate application forms. The permit, once approved, carries a minimum annual fee of \$600, in addition to requiring regular monitoring of the discharge for a number of chemical tests by a certified laboratory
- To avoid the expense, convert the existing tank to a holding tank and block off the outlet and operate it as a holding tank. A photo of the plugged off outlet after the work is completed is required.

## **Resolution 69**
