The meeting was opened with Salute to the Flag led by Supervisor Todd Bradt.

Ivan Duesler made a motion to pay General bills, Abstract # 11, Claim # 135 thru 142 in the amount of \$3,238.69. 2<sup>nd</sup> by George Cosselman. 5 Ayes. Carried.

Thomas Miles made a motion to pay Highway bills, Abstract #11, Claim # 159 thru 166 for the amount of \$10,468.10 2<sup>nd</sup> by Ivan Duesler. 5 Ayes. Carried.

### **Communications:**

- The Town received notice from the Fulton County Dept of Solid Waste that Ephratah Transfer Station will be closed Thursday November 24<sup>th</sup> for the Thanksgiving Holiday. They will reopen Saturday regular hours.
- DEC is having a public hearing at the Town of Johnstown Town Hall on November 15<sup>th</sup> at 5:30pm regarding state lands in Fulton County. It pertains to the Rockwood and Lassellsville State Forest in the Peck Hill area. They are looking for any public input on what to do with this land and how to make this area more user friendly.

- Highway purchased the screen plant from Stratford. They brought it down and it is in the pit. It will be inspected and put into service next year.
- The Supervisor is still evaluating truck #7 and the transmission.
- They had a visit Monday from M-Shaw which was expected. They had a good meeting and it was very informative.
- They are cleaning up and getting ready for winter. They have another sander to put on.

### Assessor:

- They are collecting data from parcels with new permits up until March 1, 2017.
- They will be mailing renewals out for the Enhanced Star, Senior, Agricultural, and Non-profit exemptions soon.
- All Enhanced Star and Senior Exemptions that began with the 2016 tax roll will need to be renewed with the state, not the local assessor.

### Historian:

#### **Resolution 78**

Ivan Duesler offered Resolution 78 authorizing Supervisor Bradt to enter into an agreement with James A. Brennan Memorial Humane Society for the year of 2017. #### **Resolution 79**

Ivan Duesler offered Resolution 79 to adopt the preliminary budget of \$1,421,997.00 the amount to be raised by taxes of \$829,409.00 as the annual budget for the Town of Ephratah for the fiscal year 2017.

Resolved: Whereas, the town board has met at a time and place specified in the Notice of Public Hearing on the preliminary budget, and heard all persons desiring to be heard thereon, Now therefore be it resolved that the town board does hereby adopt such preliminary budget as amended as the Annual Budget as so adopted, be entered in detail in the minutes of the proceedings of the town board and be it further resolved, that the town Clerk or Budget Officer of the town, shall prepare and Certify in duplicate copies of said annual budget as adopted by this board together with estimates if any, adopted pursuant to section 202-A. sub-division 2 of the town law, and deliver a copy thereof to the supervisor of this town, to be

presented by him to the board of supervisors of the County. This resolution was  $2^{nd}$  by Thomas Miles.
