The meeting was opened with Salute to the Flag led by Supervisor Todd Bradt.

Ivan Duesler made a motion to accept the August 9, 2017 regular meeting minutes. 2nd by George Cosselman. 5 Ayes. Carried.

Ivan Duesler made a motion to pay General bills, Abstract # 9, Claim 133 thru 148 in the amount of \$25,667.45. 2nd by George Cosselman. 5 Ayes, Carried.

Thomas Miles made a motion to pay Highway bills, Abstract #9, Claim 136 thru 157 in the amount of \$149,319.53. 2nd by Ivan Duesler. 5 Ayes, Carried.

Communications:

- The Fulton Co DSW sent notice in that the Ephratah Transfer Station will be closed on Monday, October 9, 2017 for the Columbus Holiday. The station will be open on Tuesday, October 10th from 10am till 6pm.
- DEC has announced free fishing days in NY State. The dates are as follows: September 23, 2017, National Hunting and Fishing Day. Also November 11, 2017 Veterans Day, February 17-18, 2018 weekend preceding Presidents Day and June 23-24, 2018 the last full weekend in June 2018.

Public Hearing:

• Opened the public hearing at 6:15pm for the Local Law 1 of 2017 amending Sub-Division Regulations Local Law 1 of 2016 to add Simple Spits, (0-2).

Reports:

Code Enforcement Officer:

- Five new permits were issued.
- Four Certificates of compliance were issued.
- Mr. Rackmyre reported that he had spoke with the owner of the second hand store in Rockwood. There is too much stuff piled in the building. The councilman pointed out it could be a fire hazard. Mr. Rackmyre also spoke with this owner about his property on Church Street that has been an ongoing issue.

Planning Board:

- They met on Monday September 11th, 2017 at 6pm at the Ephratah Town Hall.
- The Planning Board has 2 Alternate vacancies.
- They discussed the officer slate for December elections.
- Mrs. Weaver inquired if our area has any emergency plans. Supervisor Bradt said they would likely meet at the firehouses and or Town Hall.

Highway:

- Highway Superintendent, Mr. Cretser stated that the blacktop has been done and that they are finishing up the shoulders.
- Mr. Cretser also stated that they are almost done mowing on the side of the roads. They would like to be screening gravel for a couple more weeks, and then start sand.
- They are also working on the trucks for winter and working on the insurance company suggestions.

Youth:

- The Car Show was held August 12th from 11am till 2pm, special thanks goes out to Judy Townsend and June Frasier for all their help.
- Soccer started September 9th at 10am and it wasn't as good of turnout as they had hoped.
- They will hold the Soup and Sandwich on the last day of Soccer, October 14th, 2017.
- They are also working on some insurance requests.

Assessor:

- Ms. Yuenger is entering all sales including splits and mergers and then will begin entering new values after the data collection later on in the year.
- She has registered for the final 6 hour class. (They need 12/year.)
- She is finding improvements being made without permits and an increased volume of "junk". She has suggested a local law to discourage this.
- The assessor's office will be sending out exemption renewal notices in November and would like to remind people that will turn 65 anytime next year to apply for the Enhanced Star and Senior exemptions before March 1st, 2018.

Thomas Miles offered Resolution 62 to accept Local Law 2 of 2017 "Notice of Highway Defects, Notice of Claims to be put in Writing" 2nd by Andrew Chorlton. 5 Ayes, Carried.

<u>Local Law Number 2 of 2017 "Notice of Highway Defects, Notice of Claims to be put in Writing"</u>

A local law providing for written notification of defects and obstructions on town highways, bridges, streets, sidewalks, crosswalks and culverts in the Town of Ephratah.

Be it enacted by the Town Board of the Town of Ephratah.

No civil actions shall be maintained against the town or town Section 1. superintendent of highways for damages or injuries to person or property sustained by reason of any highway, bridge, street, sidewalk, crosswalk or culvert being defective, out of repair, unsafe, dangerous or obstructed unless written notice of such defective, unsafe, dangerous, or obstructed condition of such highway, bridge, street, sidewalk, crosswalk or culvert was actually given to the town clerk or town superintendent of highways, and there was a failure or neglect within a reasonable time after the giving of such notice to repair or remove the defect, danger or obstruction complained of. No such action shall be maintained for damages or injuries to person or property sustained solely in consequence of the existence of snow or ice upon any highway, bridge, street, sidewalk, crosswalk or culver, unless written notice thereof, specifying the particular place, was actually given to the town clerk or town superintendent of highways and there was failure or neglect to cause such snow or ice to be removed, or to make the place otherwise reasonably safe within a reasonable time after the receipt of such notice.

Section 2. The town superintendent of highways shall transmit in writing to the town clerk within ten days after the receipt thereof all written notices received pursuant to this local law and subdivision 2 of section 65-a of the Town Law. The town clerk shall cause all written notices received pursuant to this local law and subdivision 2 of section 65-a of the Town Law, to be presented to the town board within ten days of the receipt thereof or at the next succeeding town board meeting whichever shall be sooner.

Section 3. This local law shall supersede in its application to the Town of Ephratah subdivisions 1 and 3 of section 65-a of the Town Law.

Section 4. This local law shall take effect immediately upon its filing in the office of the Secretary of State.

Please note that Town Law 65-a, Subdivision 4, requires the Town Clerk to keep a separate indexed record of all such notices received. In the event of litigation, the Town will be expected to demonstrate compliance with this provision.
