Reports:

Code Enforcement Officer:

- Code Enforcer, Devon Percival had a call concerning garbage on Rte 67. They would like Code Enforcement to address.
- There was also a complaint on New Turnpike about a garbage truck.
- We have received the flood zone map from FEMA.

Planning Board:

- Mr. Barker was in for a simple subdivision request on New Turnpike Rd.
- The Planning Board will be meeting in September for the quarterly meeting.

Highway

- Highway Superintendent, John Polenski Jr. and his deputy Steven Cornaire reported that the mower with sickle bar parts were costly and not doing a good job. They spoke on flail mowers that hook to tractors and run off the pto; and that they like the hammer blades on those mowers.
- Mr. Polenski Jr. reviewed and updated the insurance policy saving the town money that will be reimbursed. He will also be doing an updated list for tool values that could add to the policy.
- The fiber matting they put down and shoulders are all done.
- They met with DOT and want to make the intersection smaller on Rte 67 and Turn Hill to fix a water issue with the culvert.

- Highway has a position open for an MEO that they will be advertising. They did hire a laborer.
- The Highway Dept will not be doing the Cemetery Rd project this year but may do the culvert. DEC may still want them to do the work next year.
